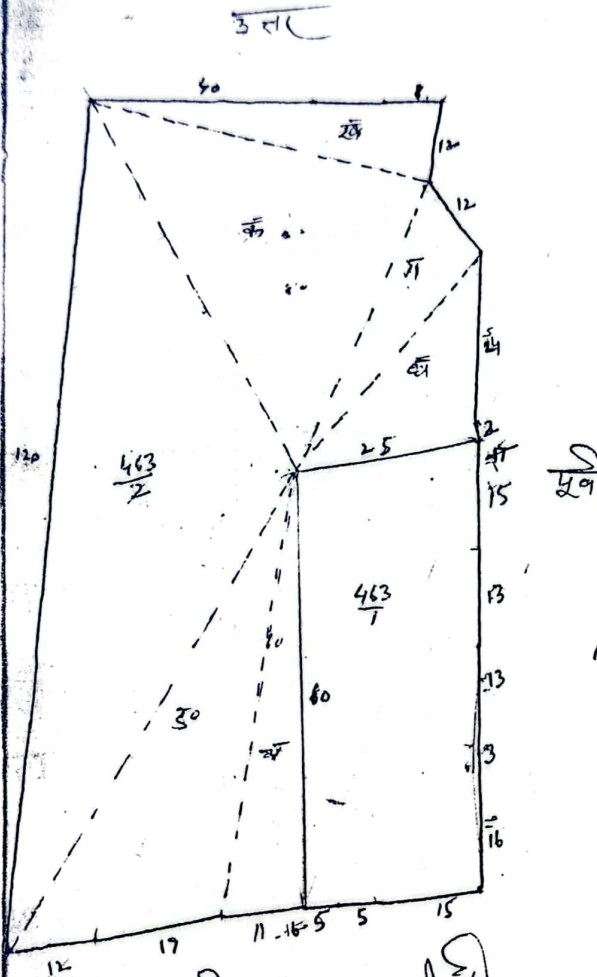

RULES AND REGULATIONS OF THE SOCIETY

MEMBERSHIP :- Every person who has attained the age of eighteen years can become the member of the Society provided he/she having sound mind and not declared insane by any court of law and if his/her application for membership is approved by all the founder members of the Society. However he/she shall become member after attaining age of maturity.

MEMBERSHIP FEE :- Every member has to pay once Rs. 1000/- as admission fee and Rs. 100/- towards annual renewal of membership subscription which will be payable compulsory in the month of January every

RENEWAL OF MEMBERSHIP :- The membership of any member who will not pay annual specified fee will be treated as canceled how ever executive council has to renew his/her membership within a period of one month if he/she clears all the subscription with monthly fine of Rs. 10/- daily in case payment of the annual subscription the member has to apply to the society for membership and has to pay all the dues of the society and the subscription fee.

The membership of any member will be canceled with 80% majority of the House meeting if he/she will work against the objects of the society. He/she will be given 15 days time to reply for his/her defence.

MEETING :- General body will constitute all the members of the society. All the members who have not paid annual subscription within a period of three months shall not be entitled to attend the meeting. The quorum of general meeting will be 1/3rd of the total number of the members. In case of tie the chairman of the society will have the right to cast one final decisive vote.

EXECUTIVE COUNCIL :- The executive council will be elected by the majority in the annual general meeting of the society for a period of three years. The executive council will constitute the following office and members, Chairman, President, Vice President, Secretary, Treasurer.

POWERS OF EXECUTIVE COUNCIL :- The executive council shall be responsible for all the powers which have been vested under the Societies Registration Act 1960. The executive council shall be assigned the power to fix remuneration to any of the members who are employed in any duty.

PROVISIONS OF THE VACANCIES OF THE EXECUTIVE COUNCIL :- In case of any vacancy arising in the executive council due to resignation or death of any member of the council then the executive council will be filled up for the rest of the period out of the general body with the consent of all the members. No executive council member can exercise his/her vote in any matter in which he/she will be interested. No member of the council can hold any assignment in the society except honorable post. The management committee shall have the powers to accept or reject the appointment.

CONSTITUTION OF THE EXECUTIVE COUNCIL :- The management committee shall constitute the following members of the society Chairman, President, Vice President, Secretary and Treasurer.

FUNCTIONS OF EXECUTIVE COUNCIL :- To prepare annual budget and income & expenditure account of the society for approval at the annual general meeting.
 To accept arrange donation grants & Loans for the society.
 To impart special power to president, Vice President or Secretary.
 To utilize the funds of the society for the best interests of the society.
 To appoint administrative, educational and subordinate staff for running any activities of the society.
 To hold control over all the activities of the society including annual financial reports of the administrative/educational staff.

MEETINGS OF EXECUTIVE COUNCIL :

Meeting of council will be held atleast once in three months and in addition to this if need be there, then the meeting of the council called at other time also. The quorum for the meeting shall be 2/3rd of total members. Meeting of the executive council can be canceled if non completion of quorum but the same meeting can be called within the next 10 days, in the quorum do not get completed in the next called meeting then members present will complete the quorum and the agenda points will be the same as previously taken for the meeting.

Agenda points were sent along with the notice of the meeting to members, however the effect of postponement of the meeting for want of quorum shall be carried to the next meeting.

ANNUAL MEETING :-

Annual General Meeting of Society shall compulsorily be called once a year but in any circumstances it can be called earlier also. If quorum of the annual meeting does not get complete within one hour of the meeting the meeting shall be canceled and be called again within fifteen days of meeting, the quorum shall be treated as complete with the number of members present but only the original agenda points which are to be discussed earlier shall be considered in the adjourned annual meeting.

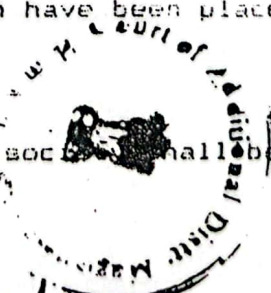
FUNCTIONS OF THE GENERAL MEETING OF THE SOCIETY :-

- 1. To settle down the matters relating to removal of members.
- 2. To elect the executive council through democratic manner.
- 3. To appoint the auditors of the society.
- 4. To discuss and consider all the points which have been placed before the body meeting by executive council.

AMENDMENT IN RULES AND SUBRULES OF THE SOCIETY :-

Generally all the rules and subrules of the society shall be amended with the majority of general house meeting.

AUDIT OF THE ACCOUNTS :- The accounts of the society shall be audited by Chartered Accountants who shall be appointed every year at the annual general meeting of the society.

POWERS & DUTIES OF THE OFFICE BEARERS OF THE SOCIETY :-

CHAIRMAN :- The Chairman of the society shall be the chairman of all type of business of the society. The chairman shall be having a right to cast one additional vote in case of tie matter in the meeting.

PRESIDENT :- The President shall be responsible for carrying on all the activities of the society in the efficient manner and he shall be constitution executive head of the society. He shall exercise the necessary power to implement to the aims and objects of the society. He will preside over all meeting of the society in the absence of chairman.

VICE-PRESIDENT :- The vice president will exercise all the powers of the president in the absence of president.

SECRETARY :- The secretary shall look after working of the society and shall attend the meetings of the general executive council with the permission of the president. The secretary will record all the minutes of the meetings in the statutory books and inform about the various resolutions to be passed in the meeting.

The President and the Secretary shall submit confidential reports of the educational institution run by the society and forward it for approval to the Chairman of the society.

TREASURER :- The treasurer will work according to the instruction of the executive council. The treasurer will keep cash balance upto Rs. 200/- in possession for petty expenses and will spend the money for best cause of the society. The treasurer shall get all the expenses incurred by the executive council and issue receipts for any type of donation/grants on behalf of the society.

SOURCE OF THE SOCIETY :- The society shall be having income from these

Admission fee received from members.

Annual Subscription received from members.

Donation/grant received from public as well as Govt. institutions.

Loan raised for the cause of the society from any bank/financial institution/former members.

Fee received from the students of the educational institution run by the society.

The fund of the society shall be kept in any post office account or bank and that account shall be operated jointly by the Chairman,

& Secretary no single person of the society shall be authorised to open any bank account or post office account on behalf of the society.

ASSOCIATE MEMBER : If the society thinks proper then associate members can be appointed from various walks of life i.e. from the field of education, culture, technical. These members shall not be having right to vote but will be treated for fulfillment of the quorum of the meeting.

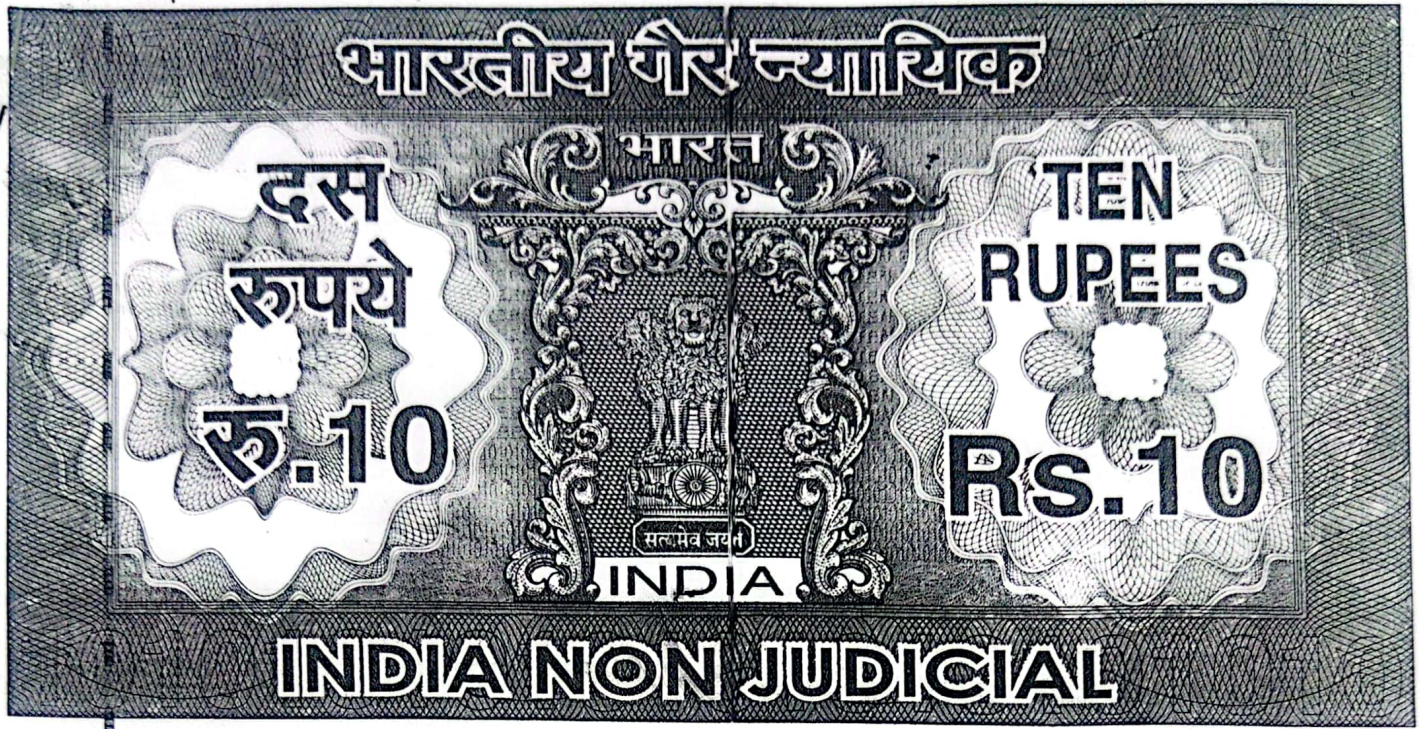
